

# Terms and Conditions – myMBRAUN Mobile Web Application

**Last updated: January 24, 2017**

Please read these Terms and Conditions ("Terms") carefully before using the myMBRAUN mobile application (the "Service") provided by M. Braun Inertgas-Systeme GmbH, Dieselstr. 31, 85748 Garching, Germany ("MBRAUN").

Your access to and use of the Service is conditioned upon your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who wish to access or use the Service.

By accessing or using the Service you agree to be bound by these Terms. If you disagree with any part of the terms then you do not have permission to access the Service.

## **Accounts**

When you create an account with MBRAUN, you guarantee that you are at least 18 years of age, and that the information you provide MBRAUN is accurate, complete, and current at all times. Information regarding your glove box parameters such as oxygen and moisture content, box pressure, freezer temperature, alarm points, glove box trends, set points and all other information will be data the Service stores on a server which will be accessible by MBRAUN and MBRAUN subsidiaries.

By using the Service you agree to allow MBRAUN and MBRAUN subsidiaries access to information for MBRAUN sole discretion including but not limited to a.) Access to stored data on the Services server b.) direct maintenance recommendations via email contact and/or phone call from MBRAUN authorized sales and services personnel c.) data being collected and exported directly from the Service to use for product analysis and performance measurements.

### **Privacy Policy**
